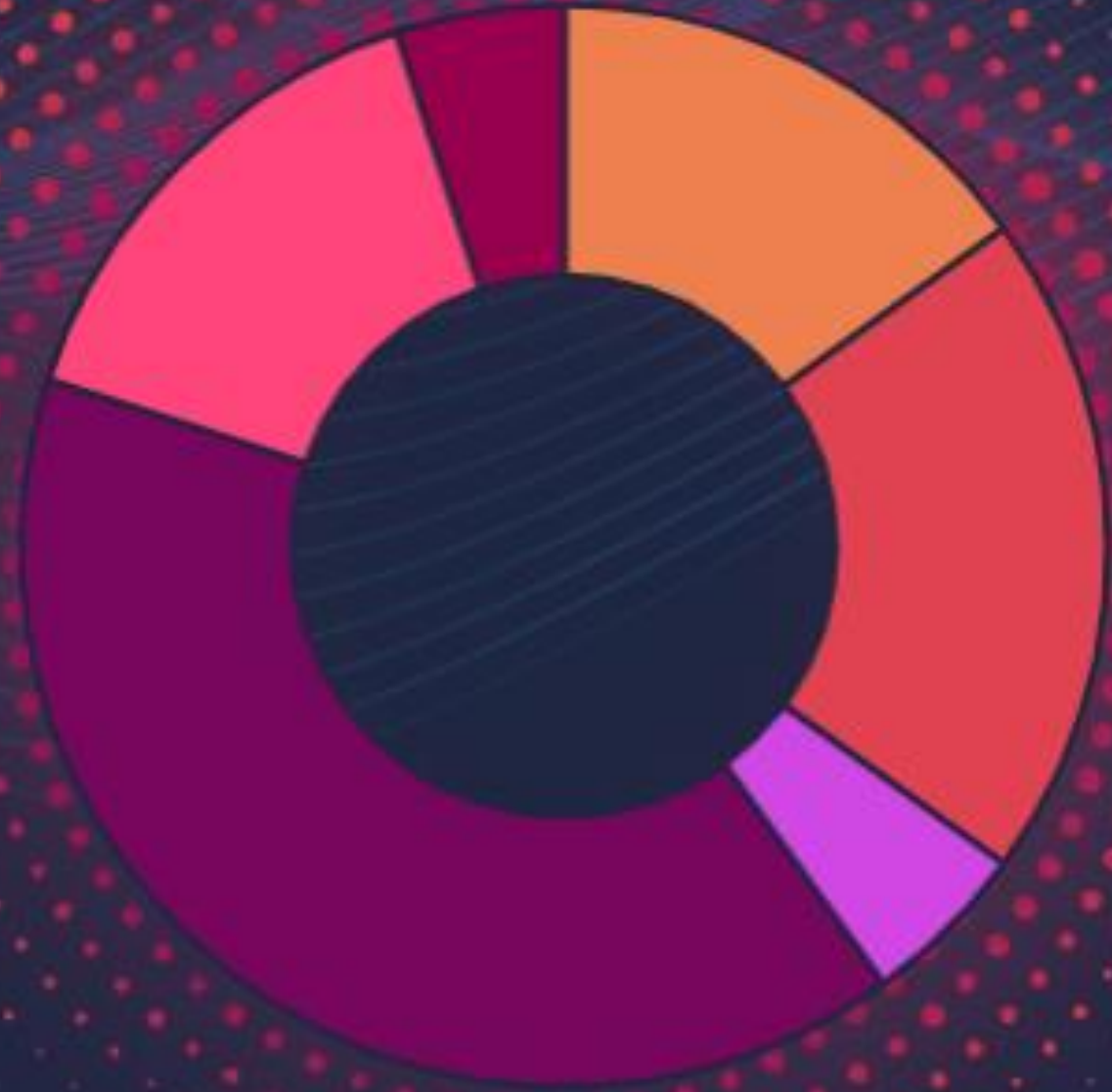
## General description

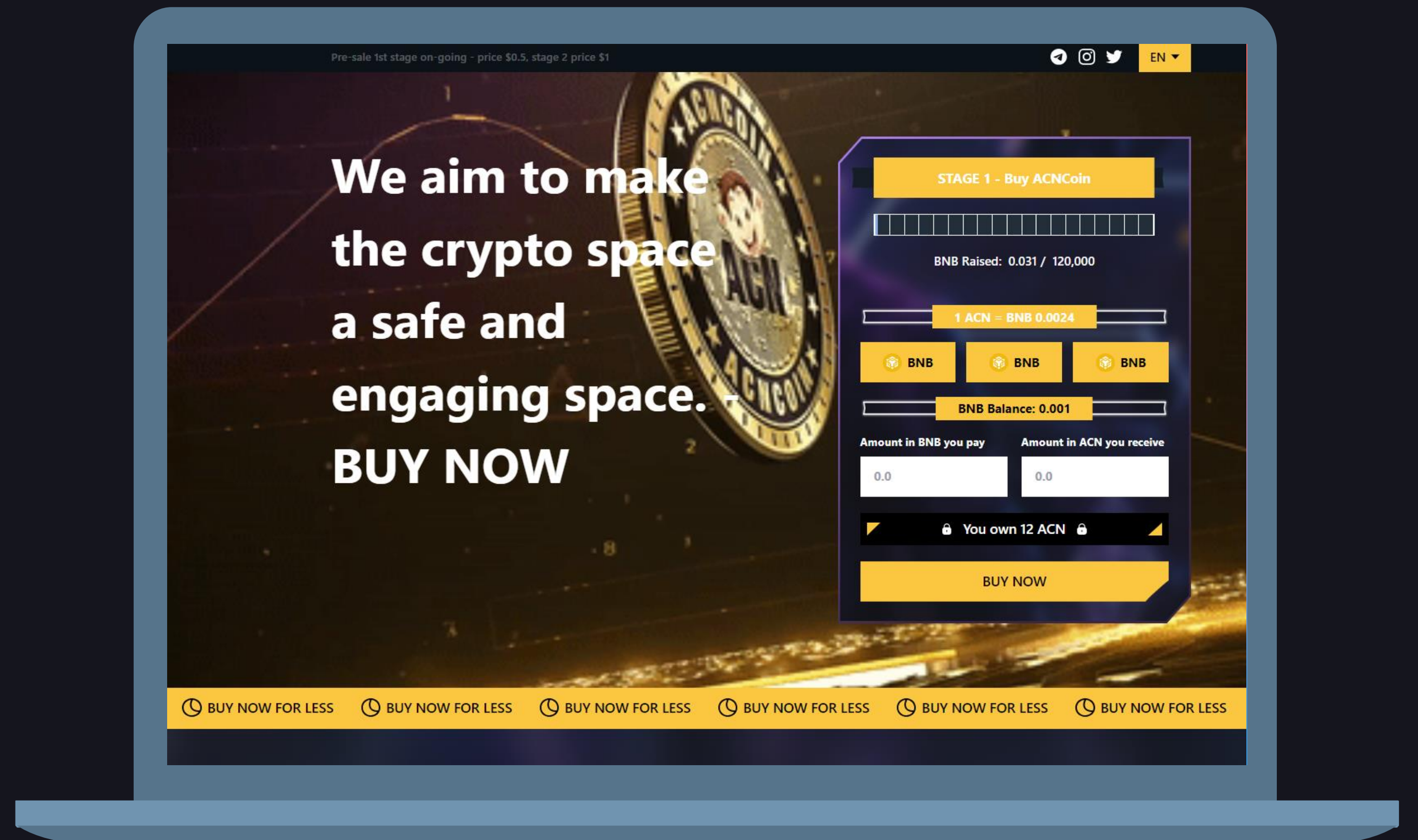
